PRECAUTIONS ON INSTALLATION & WIRING

 **WARNING** *Negligence could result in death or serious injury.*

- When existing chime wires are used, be sure to locate and disconnect the bell transformer. 
Unit damage or electric shock could result. Ask qualified personnel.
- Do not change or alter KB-DAR. It can cause fire or electric shock. 
- Video door station is weather-resistant, but do not spray water directly on video door station to prevent electric shock. 
- Make sure wires are connected properly before plugging in power supply. Fire or electric shock could result. 

 **GENERAL PRECAUTIONS** –  mark indicates caution statement (incl. danger and warning), which is specifically shown inside.

 **GENERAL INSTRUCTIONS** –  mark indicates contents which demand a specific action shown inside or attached.

 **GENERAL PROHIBITIONS:** –  mark indicates contents which prohibit a specific action shown inside or attached.

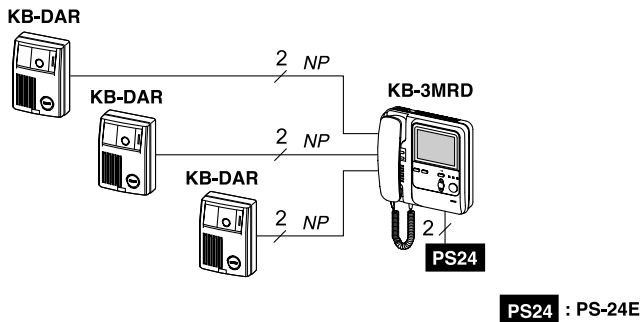

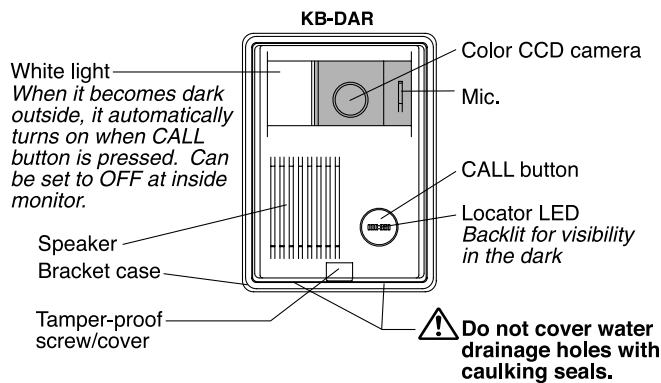
1 SYSTEM OUTLINE & COMPONENTS

KB-DAR is a video door station for use with KB-3MRD system. Up to three KB-DAR's can be connected to master station.

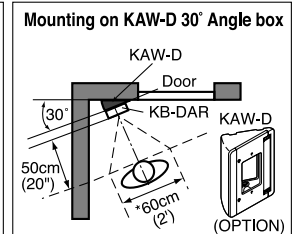
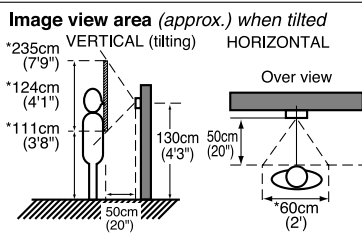
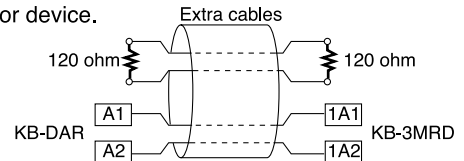


- Features**
- 2-conductor non-polarized wiring
 - White LED light auto turn on or off
 - Single-gang surface mounting

3 INSTALLATION

Wiring precautions

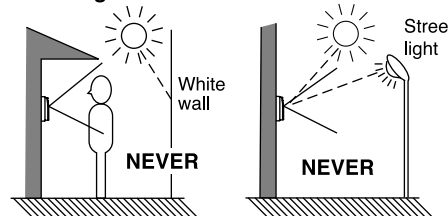
- Keep video wires more than 30cm/1' away from AC 100 ~ 240V power lines.
- Employ 2-conductor parallel wires only. Specify **PE (polyethylene) insulation, vinyl-sheathed**. Coax-cable cannot be used. For other types, normal operation or max. communication distance cannot be guaranteed.
- When existing cable is used, install a 120Ω resistor at both ends of unused wires.
- Do not mix audio/video wires with those of another video door station or device.



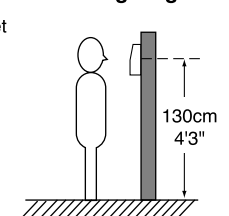
Mounting locations & height

- Do not install a video door station in the following locations;
- Places subject to temperature/humidity extremes.
 - Places near dust, vapor, smoke and chemicals.
 - Places where a call is strongly backlit (bright background).
 - Places where direct sunlight or strong light comes into the camera lens.

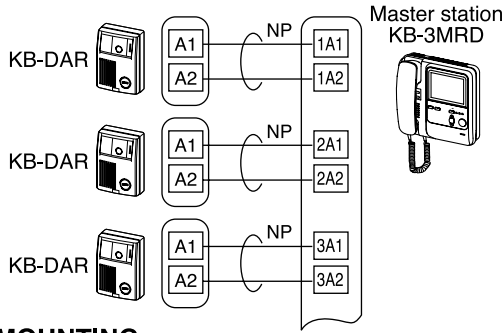
Mounting locations



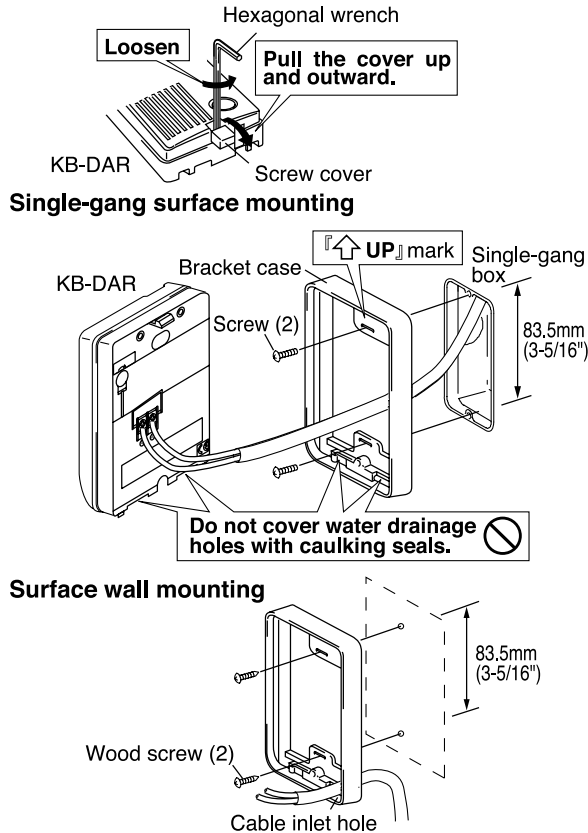
Mounting height

6 OPERATIONS

Calling

Momentarily press CALL button on video door station. After room station replies, talk hands free in front of camera.

Instant-On audio/video

After chime tone sounds, inside stations see image and hear audio of door without lifting handset.

7 TECHNICAL PRECAUTIONS

Caulking seals: Do not apply any caulking seals around video door station. Water drainage holes on bottom will help water or moisture to dissipate.

Cleaning: Clean KB-DAR with a soft cloth dampened with neutral household cleaner and cloth. Do not spray high-pressure water on video door station.
